The B.O.G. welcomed the nomination of new members andhope new members will take pain for their presence from the next B.O.G. meeting in the benefit of the institute. The Principal also thanked the Chairman and all the members for attending the meeting inspite of their busy schedule.

The Principal gladly apprised the Board in detail on the under mentioned issues with Power Point presentation.

Building

As advised by the B.O.G. in the first meeting the D.S.T. sanctioned the allotment of 33.81 crorefor construction of building in the main campus. The construction of Academic Building is started. This will solve our space problem togreatextent.

Faculty

- Two regular faculty has joined the institution in the department of Computer Sc. & Engineering. However, Dr. R.K. Singh Associate Professor, Mechanical has been transferred to M.C.E., Motihari.
- Two Faculty of Civil Engineering Mr. Rakesh Kumar Yadav & Mr. Atul Kumar Agrawal have been transferred by N.P.I.U. to other institutions.
- ❖ Presently, the institution has 11 regular faculty and 35 contract faculty members that makes it a total of 46 faculty out of 64 sanctioned post.

Faculty Training

The B.O.G. discussed the details of minutes of the 2nd meeting & Action Taken Report. As the G.S.T. registered Tour & Travel Agency is not available in Darbhanga, So the B.O.G. discussed it with CA Mr. RiteshAnand, His expert advice is "The registration for GSTIN is mandatory for the local service providers required only when the annual turnover of the service provider exceeds Rs.-20,00,000 per year. Hence based on the local conditions and strength of turnover, GSTIN are not

available for majority of service provider, who are providing competitive rates, Therefore the Bill for the services and small purchases (e.g. travel, tour etc) may be accepted without GSTIN.

The B.O.G. accepted the advice of Chartered Account and accordingly the B.O.G. allowed the institute to hire the Buses & small Vehicles for different activities of the institute without G.S.T. Bill and make payment the bill without G.S.T. Also for small items to be purchased and servicesthe Bill without G.S.T. is allowed for payment to the vendors fulfilling the above criteria.

Agenda-4: Approval of Procurement Plan

The Principal presented the lists of equipments prepared department wise (Annexure- 1).for coming 18 months procurement plan. He also informed that the A.K.U., implemented the A.I.C.T.E. Curriculum from 2018-2019 session in the month of August. Accordingly the modification in the list is required.
