Terms & Conditions for Vehicle

- Any person/contractor/vendor/registered travel agent may bid. They have to submit all the documents as per the format of Technical Bid and Financial Bid.
- 2. The vehicle should be in good condition and it should not be more than three years old.
- 3. The tender fee of Rs. 500/- (Five Hundred rupees only) is payable towards procuring the tender form in the form of a demand draft in favor of Principal, Darbhanga College of Engineering, Darbhanga payable at Darbhanga. The EMD of Rs. 5,000/-(Five thousand rupees only) is payable in the form of demand draft in favor of Principal, Darbhanga College of Engineering, Darbhanga payable at Darbhanga and this DD must accompany the tender paper. Without EMD, tender will be rejected straightway.
- 4. The undersigned reserves the right to reject any or all the tenders without assigning any reason thereof.
- 5. The comparatively new vehicles and of higher model will be given priority.
- The contract will be kept valid for a period of 11 months which can be extended on mutual consent basis on the same terms and conditions for further period of 11 months (maximum three times)
- Vehicles deployed should be in good running condition and should have commercial registration, current comprehensive insurance and road tax coverage, permit, fitness and driving license of driver etc.
- 8. The successful bidder should keep the vehicles in neat, clean and good running condition with seat cloth covers, which should be replaced with another set of washed covers once in a week. The contractor should carry out the periodical maintenance of the vehicles supplied and ensure that they are always in good condition.

- 16. In case the successful bidder refuses to supply vehicles ordered by Darbhanga College of Engineering, Darbhanga, it will be viewed seriously and contract will be terminated without giving any notice and their security money will be forfeited.
- 17. The bidders are directed to submit Technical & Financial Bid in separate envelopes. The Financial Bid of only the technically qualified bidders will be opened.
- 18. The evaluation of tender will be done by the concerned committee on the basis of the weightage assigned to the Technical and Financial parts.
- 19. The breakdown of weightage will be as per the following formula: Technical -50 % (Age of vehicle: 30%, price of vehicle: 20%) and Financial - 50%, The detailed breakdown of marks is provided in evaluation sheet in the section mentioned herein below.
- 20. After evaluation of Bid, the successful bidder will be informed separately.
- 21. The authorized signatory of the agency/vendor/contractor must put their initials on each page of the tender document submitted. All pages must be numbered and a note of this should be mentioned on the covering letter. The Terms & Conditions duly signed should be attached with the tender documents.
- 22. The successful bidder has to start services within 07 days of intimation. The vendor may change vehicle quoted in the tender by comparatively newer and higher model.
- 23. The full E.M.D. shall be forfeited in case of backing out of the offer before acceptance.
- 24. The award of work shall be done on QCBS basis (Quality and Cost Based Selection approach) among the technically qualified vendors after Technical Evaluation. The lowest financial proposal (Fm) shall be given a financial score (Sf) of 50 points. The financial score of the proposals shall be computed as follows:

$Sf = 50 \times Fm/F$

(F- Amount of financial Bid).

25. Formula for final score = Sf + St

Where, St= Marks awarded for Technical Proposal and Sf= The marks awarded for financial Proposal.

The Bidder scoring highest Combined Score shall be declared as preferred Bidder for award of Contract.

26. In case two or more bidders achieve the same combined score, the bidder, whose Financial Proposal results in the least cost to Darbhanga College of Engineering, Darbhanga shall be declared as selected bidder eligible for award of Contract.
